Terms and Conditions

Wings Over Iowa, LLC (WOI) raises highly trained and well cared for WHITE DOVES from pure white racing homing pigeon stock. These are also known as Rock Doves or Columba livia, and are generally smaller and more delicate than normal "pigeons". Because the white doves are very valuable, WOI will take every precaution to protect them and assure their safety. Therefore, when you order doves from WOI, you must understand and agree to the following:

Wings Over Iowa, LCC:

- Will NOT release doves if the conditions become unsafe. Therefore, we will NOT release doves indoors, at night, or during bad weather. If conditions become unacceptable for the release on the day of the release due to unforeseen circumstances such as weather, we will refund all monies and deposits 100%.
- Will NOT release doves too close to sunset. They must be able to reach home safely well before sunset. If your event goes past the scheduled release time, the doves will not be released, and there will be NO refund.
- Will NOT release doves beyond a range that they are able to safely fly home. WOI service area is shown on our website and changes from time to time.
- A handler must be present; WOI will NOT ship doves for a self-release.
- WOI promises to do the very best to assure the highest quality white dove release as possible.

Customer Agrees to:

- Pay a deposit of 50% due at the time of reservation.
- Pay the remaining balance at least two weeks prior to the event (exception for funerals and memorials).
- In the case of cancellation prior to one month before the event by the customer, WOI will refund half (50%) of the DEPOSIT.
- Cancellations made by the customer within 1 month of event, customer forfeits the FULL DEPOSIT.
- Customer will keep WOI updated and informed on the event time and location
- Customer understands that WOI will take necessary precautions to insure that the white doves are not placed at risk in any way.
- Customer agrees to communicate their wishes to WOI so that the highest quality white dove release can be presented
